Office of Financial Regulation 2025-26 Regulatory Plan

Pursuant to section 120.74, Florida Statutes, the Office of Financial Regulation (OFR) has prepared the following regulatory plan relating to laws passed in the 2025 Regular Legislative Session and other rules that the OFR expects to implement by rulemaking before July 1, 2026.

Chapter 2025-28, Laws of Florida

- a. The OFR amended Rules 69W-302.001, 69W-500.020, 69W-600.001, 69W-600.0011, 69W-600.0012, 69W-600.0016, 69W-600.0019, 69W-600.002, 69W-600.0022, Florida Administrative Code, and adopted Rule 69W-500.021, Florida Administrative Code. The Rules were effective September 16, 2025.

As noted in the OFR's 2024-25 Regulatory Plan, Rules 69V-40.070, 69V-160.0301, 69V-160.040, and 69V-560.7044, Florida Administrative Code, were expected to be implemented by rulemaking before July 1, 2025. Such rules were filed for adoption with the Department of State and became effective on March 10, 2025.

As noted in the OFR's 2024-25 Regulatory Plan, Rules 69V-160.030, 69V-160.031, 69V-160.032, 69V-160.036, 69V-160.038, 69V-160.039, and 69V-160.111, Florida Administrative Code were expected to be implemented by rulemaking before July 1, 2025.
